By accepting this agreement or by installing "SpaceEngine" (the Software) or by clicking "Install", you agree to the following terms, notwithstanding anything to the contrary in this agreement. Before installing the Software please make sure that your computer meets the minimum technical specifications for the proper operation of the Software.

## LICENSE

Copyright of the "SpaceEngine" software (the "Software") belongs to Cosmographic Software LLC (the "Licensor"). The Licensor reserves all other rights in the Software not expressly granted to you here. Subject to your compliance with these terms and conditions, the Licensor grants you a royalty-free, non-exclusive license to use or run the Software for personal, non-commercial use only, and to copy and distribute any content created with the Software (screenshots, video, textures, scripts, but not soundtrack), for personal, non-commercial educational presentations, charity and other non-commercial use. Copyright and other intellectual property laws and treaties protect this Software Product. The Software Product is licensed, not sold.
